### 5.2 Lisa Budget

Willem: What are the budgets for each year? It is a bit of unclear. 17.5k in 2023 15.5k now 12.5k signed 10.0k potentially  
The Lisa-SNT contact is moved from Henk to Rene. Rene is an improvement over Henk.

The budget cuts are also apparent across Lisa and the UT.

Maybe reinstate some sort of helpdesk? Henk told us to just figure it out with the money we have. Rene might be different, since he is more positive about SNT

### 5.3 Rent

We have a strong case that the rent might go down. The Lisa contract states that we cannot use their money on rent, which we do currently. Also, our budget is lowered.

All other associations around us are not playing as much as we do. We pay 6.8k now. The sport associations pay 2k together, while they have a 2x bigger room.

### 5.4 Lustrum

Luc Haaijer is working with Maaik + old boards to do a lustrum activity. VB has been booked.

#### 5.4.1 SNT Pings

Pings have been received well.

Pings event reflected on the Gitlab repo.

Wi-Fi might have been killed during tests.

Lisa's mishandling of Gitlab makes SNT's gitlab worked better, so people miss the SNT version.

## 7 Budget proposal 2025

Proposal to reduce loss, instead moving the budget to consumptions.

Silke: If we decide to replace the server as often as we should, we will burn through all our money real quick. (Highlighting how many financial issues we have.)

We are burning through money, so the 10k deal from Lisa is not going to be accepted by us.

Donald Duck subscription is orphaned and difficult to get rid of it. It cannot be cancelled.

People are in favor of removing the Donald Duck subscription. We already have a lifetime of comics.

Moving to a pocket subscription is a possibility.

Danielle & Willem: Include everything in the next budget. Include use of reservations.

Another idea for outreach is a guest lecture about hosting. Might fit in Q3.

### 11.6.2 Lunch lectures

Lunch lectures are expensive.

Sending people messages about lectures with free food also works.

Willem: Teachers might help promote them using canvas announcements etc.

### 11.6.3 Sponsored hardware

Silke: Any ideas for sponsored hardware? The ftp servers were sponsored before. Sponsored hardware is good for the budget. Right now, no ideas.

### 11.6.4 Additional ideas

Potential sponsors who already reached out. ID3 and Evo

Willem: Old SNT members are in some companies, might be a good idea to hit them up.

IRC infra is difficult.

Jetse: Anything you can save on servers using sponsorships, will lighten up the budget problems. Rein: Public services like FTP or IRC are really desired by sponsors.

### 11.6.5 Tangent: (Seemingly) dead committees

Some committees are not really represented at the GMM, but are quite alive. FTPcom is actually represented.

## 12 Inquiry about member administration
